With 83 percent of the vote, Carolyn G. Goodman won her third term as mayor of the city of Las Vegas on April 2, 2019. She was first elected on July 6, 2011, and her husband of 50 years and 12-year, term-limited mayor, Oscar B. Goodman, administered the oath of office. It is the only known instance of a spouse succeeding a spouse as mayor in the United States. Mayor Carolyn Goodman was also handily re-elected in 2015.

Among her priorities, Mayor Goodman has championed downtown development, improvement in inner-city schools, expansion of homeless resources, coordination among non-profit service providers, adoption of the Nevada film tax credit, and creation of the medical district and UNLV medical school. She represents the city on numerous boards and organizations, advocating for Las Vegas' \$44.9 billion tourism industry on the Las Vegas Convention and Visitors Authority, the Las Vegas Global Economic Alliance, the Southern Nevada Tourism Infrastructure Committee and the Southern Nevada Sports Committee. Additionally, she holds national leadership roles as a member of the United States Conference of Mayors (USCM), serving on its Advisory Board and as vice-chair of its Task Force on Education Reform, and as Chair of the Mayors' Business Council. In June of 2013, she hosted the 81st annual gathering of the National Conference of Mayors in Las Vegas. The USCM honored her with the Mayors' 2014 Large City Climate Protection Award.

Carolyn is well known in the Las Vegas community for founding The Meadows School in 1984, Nevada's first nonprofit, college preparatory school for pre-kindergarten through 12th grades. Carolyn planned and oversaw the entire day-to-day operations for 26 years while also raising her four children. During this time, Carolyn never had ownership of the school as it was incorporated as a 501(c)(3) entity. Furthermore, during her 26 years in leadership, Carolyn never took a salary. She retired in June 2010.



YVANNA CANCELA

Yvanna Cancela represents Nevada's 10th district in the State Senate. She was appointed to the seat in December 2016 and became the first Latina to ever serve in the Chamber. Her work during the 2017 session focused on drug cost transparency and increasing access to affordable healthcare. As a first term legislator, she chaired the Natural Resources committee and served on Commerce and Labor.

Yvanna's career has been dedicated to community engagement and mobilization.

When not in session, Yvanna works as the executive director of the Immigrant Workers Citizenship Project. She leads the state's only organization to offer free help with naturalization applications.

Previously, Cancela was the political director at UNITE HERE's Local 226, the Culinary Workers Union; the state's largest labor union. In her role, Yvanna developed the political training, strategy, and mobilization programs for members.

In 2014, Yvanna was named a White House Champion of Change for her work in the fight for comprehensive immigration reform.

Prior to her work at the union, Yvanna moved to Las Vegas to work as a field organizer for Senator Harry Reid's re-election campaign in 2010.

Yvanna has dedicated herself to ensuring that people who are often left out of political discourse have a loud voice.

Yvanna graduated from Northwestern University in 2010 with a degree in communication studies. She is a first generation college student and the proud daughter of Cuban immigrants.

Before finishing college, Jason became student body president at UNR. Recognizing the value of education, He became a faculty member at UNR. Jason then joined the charter class at the UNLV William S. Boyd School of Law, and looked after his aging grandparents in Las Vegas. While at UNLV, he continued working in the community by participating in the law school's Juvenile Justice Clinic. Prior to completing his law studies, Jason again found his place in a leadership role when he was elected student body president of the law school.

A member of the first graduating class at Boyd Law School in 2001, Jason was awarded the Barbara Buckley Community Service Award for his commitment to leadership and community service. After graduating, he clerked for the Honorable Justice Myron E. Leavitt at the Nevada Supreme Court.

After briefly working in private civil practice, Jason became a Deputy Attorney General where he prosecuted white collar criminals. In that role, he helped recover hundreds of thousands of dollars on behalf of Nevada's most vulnerable, including senior citizens who were taken advantage of financially. Jason also served on the Nevada Cybercrimes Task Force, working with other state and federal law enforcement agencies to combat crime across the internet. During his time as a prosecutor, Jason also volunteered at a local elementary school where he helped students work on their reading skills. Jason next worked as a Deputy Public Defender, defending the Constitution and protecting the rights of the accused by ensuring that the process was fair. For over three years, Jason has worked most recently as a Deputy District Attorney, advocating in Family Court to make sure that abused and neglected children in Clark County are given a chance at a safe childhood and upbringing.





Dr. Julie Beasley, a Las Vegas native, has been in private practice for 17 years. She was the first pediatric neuropsychologist in Southern Nevada who specialized in children from birth to young adulthood with developmental, medical, behavioral and learning disorders. She developed the area's first social skills groups for students with autism and other neurodevelopmental disorders. When the Grant a Gift Foundation and the University of Nevada, Las Vegas School of Medicine joined forces to help meet the needs of individuals and families living with a loved one with autism spectrum disorder, the leaders of each organization wanted Dr. Beasley at the helm. The collaboration of the two organizations, along with the philanthropic support of its namesake, Gary Ackerman, resulted in the Ackerman Autism Center, Dr. Beasley accepted the position and is the organization's first clinical director.

In her role at the center, Dr. Beasley spearheaded the move to do something never done before in Nevada. She brought clinical care, family support, research, diagnostics and behavioral therapy all under one roof. In addition, she has put together a team of professionals who genuinely want to help people improve the quality of life of those affected by autism and related conditions. Since opening in October of 2016 through the end of 2017, the center has served over 3,600 individuals and their families, a clear indication of the need for services provided by the center.


